- *Not responsible for circumstances outside our control: deteriorated boat hardware or decking, stronger than normal winds, heavier than normal snowfalls, tampering with shrink-wrap, etc.

DISCLAIMER

Marine Services, Inc. is not responsible for any damage sustained to customer's boat after the first freeze of the fall season. Freezing is defined herein as any day where the temperature reaches 32 degrees Fahrenheit (0 Celsius) or lower. Marine Services, Inc. takes full responsibility for any work performed before the first freeze of the season. Marine Services, Inc. warrants its workmanship and services rendered ONLY. Not Responsible for parts due to age and condition of boat. Agreement Expires 9 months after date of winterization.

This is a valid and binding contract and constitutes the entire agreement between parties. Any alteration of this contract will make document null and void (exception: Marine Services, Inc. approval beforehand of said alteration of contract). By signing this contract, customer hereby warrants and acknowledges that he/she fully understands this agreement and its terms, and that he/she has voluntarily entered into a signed said contract.

All places of signature, credit card information and date must be filled out entirely before work commences and paid in full.
